



## 2025/2026 Caboolture Netball Association

In accordance with CNA's Constitution noting the below:

### **Reference to 5.2. Terms of office**

*5.2.1. Subject to clause 5.2.2, the term of office for board members is two years.*

*5.2.2. Board members shall remain in office from the conclusion of the annual general meeting at which they were elected until the second annual general meeting following their election, but are eligible, subject to clause 5.2.4, on nomination, for re-election.*

*5.2.3. The board shall have the power to determine the sequence of retirements for board members to ensure rotational terms, whereby approximately one half of the board members retire in each year.*

*5.2.4. Any person who has served as a board member for four consecutive years must retire for a minimum of one year before being eligible for election to any board position.*

All nominees must hold a current Blue Card at the time of nomination.

### **Applications Legal Obligations**

1. If you have been
  - a. Convicted – (1) on indictment; or (2) summarily and sentenced to imprisonment, other than in default of payment of fines; or (3) under the *Bankruptcy Act 1966 (Commonwealth)* or the law of an external territory or another country, you are a undischarged bankrupt; or (4) have executed a deed of arrangement under the *Bankruptcy Act 1966 (Commonwealth)*, part X or a corresponding law of an external territory or another country and the terms of the deed have not been fully complied with; or creditors have accepted a composition under the *Bankruptcy Act 1966 (Commonwealth)*, part or a corresponding laws of an external territory or another country and a final payment has not been made under the composition.
  - b. Your **rehabilitation period** in relation to the conviction or bankruptcy has not expired.

If you have not been convicted and agree to the above, then you may continue completing this application.

**Applicants that are successfully voted onto the Caboolture Netball Association Inc. Board will be required to undergo a Criminal Check as per Netball Queensland Affiliation requirements.
